

Instructions for use of the form

With this form you can apply for an exemption of duties and taxes for removal goods. This exemption allows you to bring your removal goods into free circulation with a tax relief. It concerns removal goods that you wish to bring into free circulation in the Netherlands because you are transferring your principal residence from a country outside the European Community to the Netherlands or another member state of the European Community (EC member state). Your principal residence is the place where you usually reside.

The tax relief is not applicable to the following goods:

- Products that contain alcohol
- Tobacco and products that contain tobacco
- Commercial vehicles
- Non-portable materials for professional purposes.

If you also wish to import a vehicle and bring this into free circulation this should be mentioned at question 5. In case of a motor vehicle you will receive two separate permits: one for the removal goods and one for the vehicle(s).

If you wish to report a change you must also use this form. In this case only fill out question 1 and the question or questions applicable to the change you wish to report.

Conditions

In order to obtain an exemption the following conditions must be met:

- You are transferring your principal residence from a country outside the European Community to the Netherlands or another EC member state.
- You have had your principal residence outside the European Community for at least 12 months.
- The goods are part of your household.
- You have owned and used the goods for at least six months.
- You have used the goods for your household and will use them again for your household.
- You will bring the goods into free circulation within twelve months after the transfer of your principal residence.
- You will not loan, pawn, rent or transfer the goods. This applies for a minimum period of twelve months after the

date that the goods were brought into free circulation.

Annexes:

The following documents should be submitted with the application:

- a copy of your passport, including the pages showing foreign visa (if applicable).
- Documentary evidence of your registration with the Population Register of the Municipality in the Netherlands, clearly showing that you have registered coming from a country outside the EU. If your goods are destined for another EU member state a comparable document, issued by the proper authorities of that member state, can also be submitted if it proves that you have transferred your principal residence
- Inventories of all the goods to be imported, duly signed by the applicant.

If applicable the following documents should be submitted also:

- Copy of your contract of employment.
- a employer's declaration of employment.
- Copy of your work permit
- Copy of the contract of sale or lease of your living accommodation in the Netherlands.

If you also wish to bring a motor vehicle or other vehicle into free circulation please send copies of the following documents:

- Title or registration
- Purchase invoice or proof of ownership

If there is insufficient space to answer the questions you may proceed on an annex. Please clearly mention your name on the annex and place your signature.
