

# Importing Personal Property Into Honduras

## HOUSEHOLD GOODS AND PERSONAL EFFECTS

## **CUSTOMS REGULATIONS AND REQUIRED DOCUMENTS**

## **Customs Regulations:**

The customer must be present during Customs clearance. A Customs inspection is mandatory and is usually performed at the Customs site; however, the inspection may take place at the customer's residence or at the agent's warehouse. An additional charge will apply. Used household goods and personal effects are duty free for returning Hondurans who have proof of living abroad for at least 12 months and diplomats. Shipments may be held at Customs or S.I.T. in bond. If that occurs there will be a charge. Customers without a Franchise or Residence Permit must secure a guarantee. Customers relocating to Honduras will incur duty and taxes on their goods.

## **Required Documents:**

- ✓ Passport including photo page
- ✓ Residence Visa
- ✓ Work Permit & proof of Employment
- ✓ Certificate of Residence Change
- ✓ Permit to import household goods and personal effects
- ✓ Bill of Lading/Air Waybill original
- ✓ Inventory in Spanish, (no other language accepted) 3 copies, preferably typed
- ✓ Letter authorizing Destination Agent to clear shipment
- ✓ Franchise (Dispensa) for Returning Hondurans, secured through an attorney after arrival

## **Diplomat Status:**

Foreign diplomats, members of government or international organizations are granted tax and duty free entry of their personal effects and household items either new or used.

## **Required Documents:**

- ✓ Diplomatic Franchise (Dispensa) Secured through an attorney upon arrival
- ✓ Passport copy
- ✓ Inventory in Spanish, 3 copies, preferably typed

#### RESTRICTED/DUTIABLE ITEMS

- ✓ Electrical appliances & new items require original receipts with four copies
- ✓ Sporting firearms require a permit from the Secretary of Defense and the Treasury
- ✓ Alcohol; 1 bottle of spirits duty free, in excess of that will incur high tax and duty
- ✓ Tobacco; 1 carton of cigarettes or 1 lb loose leaf or 250 cigars are duty free in excess of that will incur high tax and duty

## PROHIBITED ITEMS

- ✓ Narcotics/illegal drugs of any kind
- ✓ Pornography, subversive literature and films
- ✓ Explosives, ammunitions and all weaponry such as knives, swords, knuckle dusters

#### **IMPORTATION OF PETS**

Dogs and cats must be accompanied by veterinarian health certificate issued at point of origin, and an import permit from the "Direccion General de Ganaderia y Veterinaria" (General Direction for Cattle Breeding and Veterinary Services). Dogs also require an additional rabies vaccination certificate and distemper and hepatitis certificates. The entry permit can be arranged upon arrival. Quarantine is not required for pets coming from the United States certificates must be certified by the USDA. All documentation must be in Spanish

## **Required Documents:**

- ✓ Certificate of Vaccination including rabies, dated less than 30 days prior to arrival
- ✓ Health Certificate dated less than 10 days prior to arrival.
- ✓ Import Permit

#### IMPORTATION OF VEHICLES

Only diplomats and international organizations are allowed to import a vehicle. Vehicles can be new or used. They are duty free but subject to high taxes. Documentation below must indicate make, model, year of manufacture the engine's cc's. Tax rates are assessed based on the vehicle specifications. Specifications vary; please seek the advice of your Destination Agent prior to consigning a car for current requirements

#### **Required Documents:**

- ✓ Certificate of Title and Registration must be original
- ✓ Commercial/Purchase Invoice must be original
- ✓ OBL and Passport

#### **NOTES:**

Fumigation of Wood Packing Materials: Honduras has adopted measures in accord with ISPM15 for wood packaging material (WPM).

**Documentation:** US citizens are advised to carry a copy of their passport with them at all times while in Honduras. Travel into bordering countries: In June 2006, Honduras entered a "Central America-4 (CA-4) Border Control Agreement" with Guatemala, El Salvador, and Nicaragua. Under the terms of the agreement, citizens of the four countries may travel freely across land borders from one of the countries to any of the others without completing entry and exit formalities at immigration checkpoints. U.S. citizens and other eligible foreign nationals who legally enter any of the four countries may similarly travel among "CA-4" countries without obtaining additional visas or tourist entry permits for the other three countries

Health: Honduras has the highest adult HIV/AIDS prevalence rate in the region. Some HIV/AIDS entry restrictions exist for visitors to and foreign residents of Honduras. For these individuals, medical certificates are required. Please verify this information with the Embassy of Honduras before you travel.
